## Pre-Kindergarten

**Updated Health History form due on or before the first day of school.**

**Updated immunization record and physical due on or before the first day of school.**

**NOTE:** If in Pre-K for more than 1 year, no follow up physical required until Kindergarten; however, documentation of updated annual vaccines is required.

## Kindergarten

**Updated Health History form due on or before the first day of school.**

**Physical exam** performed and documented on the Illinois Certificate of Child Health examination form completed by MD, PA, or APRN along with vaccines (DTAP, Polio, Varicella, MMR)

**Eye exam** performed by an ophthalmologist or optometrist with completed State of Illinois eye exam form

**Dental Exam** performed and documented by dentist on the State of Illinois dental form.

## Grade 1

**Due First day of school:** Updated Health History form only, no other requirements needed.

## Grade 2

**Due First day of school:** Updated Health History form

**Dental Exam** performed and documented by dentist on the State of Illinois dental form.

## Grade 3

**Due First day of school:** Updated Health History form only, no other requirements needed.

**Grade 4**

**Due First day of school:** Updated Health History form only, no other requirements needed.

**Grade 5**

**Due First day of school:** Updated Health History form only, no other requirements needed.

**Grade 6**

**Due First day of school:** Updated Health History form

Physical exam performed and documented on the Illinois Certificate of Child Health examination form completed by MD, PA, or APRN, including **Immunizations (Tdap, Meningococcal)**. (optional HPV)

Dental Exam performed and documented by dentist on the State of Illinois dental form.

**Grade 7**

**Due First day of school:** Updated Health History form

**Grade 8**

**Due First day of school:** Updated Health History form

**NOTE:** All students who are new to the State of Illinois are required to have a **physical exam** documented on the Illinois Certificate of Child Health examination form with completed **Immunizations**, an Illinois **Eye Exam** (submitted within 30 days of start date of school), and an Illinois **Dental Exam** (or waiver), as well as an updated Health History form. All requirements are due upon the start of school.

**NOTE:** A school physical completed on the "Certificate of Child Health" form, can be used as a sports physical. However, a sports physical **CANNOT** be used as a school physical.

**Illinois state law requires all updated immunizations and required grade level physicals be turned into the school office no later than October 15, 2023. After that date, students will be excluded from school attendance until all documents are completed and submitted to the school office.**

**Medications/Health Action Plans:** Administration of ANY medication requires both a physician's written order and signed parental permission on the SCHOOL MEDICATION AUTHORIZATION form.

**ANTIBIOTICS** and short term over-the-counter medications (Tylenol, Ibuprofen, cold medications, etc.) will **not** be given at school. Also, cough drops will **not** be provided at school.

**Food Allergy/Asthma/Seizure/Diabetic Medical Management Plans** must be signed and completed accordingly by a licensed MD, PA, or APRN and turned into the school office.
